4.06.20) Matters arising from the minutes (not included on agenda)

6.06.20) Treasurer's report

i/ We had applied for and received a Covid grant of £10000 through the council and it was now in our bank account. The grant was to be regarded as a reserve in part to offset loss of revenue incurred due to the Covid regulations. Treasurer confirmed that it was a grant and NOT a loan. There may be tax implications at the end of the year. The use of the cash would be strictly monitored.

iii/ Spare cheque signatory still to be sorted, issue was with the bank forms. The club has the required signatories for cheques.

Bowls England warning about legionella disease was discussed and it was agreed that we were not at risk.

General discussion about Risk Assessments took place as it was 2 years since they had taken place and we had no evidence that they had taken place. David to contact Roy about the last assessments and if he had copies of the paperwork. David would then undertake the assessments.

9.06.20) Recruitment

Membership is a serious problem for the club and with the Covid regulations we were not able to use the normal sources that we had used in the past. The grant money does not solve the clubs problems regarding membership. With little chance of an open day advertising should be considered The Big publishing Company was mentioned as a magazine source. Use of Jamaica visit in 2022 was to be considered.

Booking showed that there was a preference for Monday afternoon and Monday and Friday evenings

Run a 2 wood league with a fixed jack on Bank Holiday Monday

Club singles in early September possibly over 12/13 September weekend

Face coverings to be used if it made members more comfortable

Facilities Reopen clubhouse and stop access to the kitchen

Hygene bar to be deep cleaned and restocked Wednesday prior to opening on Saturday Adjust tables in clubhouse on Wednesday to achieve required distancing Gel required - needs to be at least 70% alcohol Disinfectant - use Dettol or bleach

Grounds consider waiter service, or one person per rink to order

Use changing room corridor as a one way tea pick up point, members to serve themselves
