6) Treasurer's report

The club has been notified that the insurance costs will go back to normal with no discounts and green maintenance costs will also lose its Covid discount.

Emergency lighting and fire extinguishers have been serviced and the go ahead has been given for remedial work to be done.

Accounts, Berlin's have notified us that because of Covid grant we obtained in the last financial year we will be subject to Corporation tax. The Club was aware that this situation may arise when we applied for them

Ater some discussion the proposal is that we carry over membership paid from last year to this year for those renewing their membership.

7) Alternate AGM format

In order to get the delayed AGM carried out, It was decided the we would do a Postal AGM. 8) Review opening date and opening day requirements

The questionnaire canvassed interest in the leagues that the club normally entered and as a result the Club had withdrawn from the BBA, BDWBA due to lack of players.
